Revised Guidelines for Online Arrear/Repeat End sem Examination, June 2021

9. Pdf copy of the question paper would be sent to students 5 min before schedule exam time through Google Classroom/WhatsApp by the concerned Invigilator cum coordinator as indicated in the notified time table.
10. Students have to write their answers on single side of plain A4 papers. The first page should contain the following basic information. Answer should be written from 2nd page

11. All the pages should be serially numbered, starting from the first page, at top of the page. The student should put his/her signature at right top corner of the first page.
12. After complete writing, the answer scripts have to be scanned serially (including declaration and undertaking at the end) and submitted as a single pdf file to the concerned Invigilator cum coordinator preferably in Google Classroom. The pdf file should be named as below

13. Students are advised to use **DOC Scanner** android app (<https://play.google.com/store/apps/details?id=com.cv.docscanner>) for scanning the answer scripts. This app significantly reduces (without compromising on the resolution) the file size which can easily be uploaded despite poor connectivity.
14. Answer scripts submitted after allotted time would not be considered for evaluation.
15. The hard copy of answer scripts (including declaration and undertaking) must be submitted to the department once university reopens.
16. For any problem regarding your question paper or uploading your answer scripts, the students are hereby asked to contact the concerned Invigilator cum coordinator.
